

**Zoznam pracovných skupín, výborov a prípravných orgánov

zúčastniť iba osoby s platným osvedčením EÚ o bezpečnostnej previerke**

Rada Európskej únie prijala dňa 21. decembra 2004 „Usmernenia o bezpečnostnej previerke zamestnancov“ (č. 16012/1/04 REV1- LIMITE), ktoré stanovujú minimálne kritériá pre postupy bezpečnostných previerok pracovníkov a tým určujú viaceré aspekty ochrany utajovaných skutočností EÚ. V nadväznosti na prijatie tohto dokumentu sú členské štáty povinné vykonať nevyhnutné kroky a opatrenia na zabezpečenie riadneho bezpečnostného preverenia osôb participujúcich na aktivitách určitých pracovných skupín, výborov a prípravných orgánov Rady EÚ.

S účinnosťou od 1. januára 2006 sa osoby, ktoré nie sú bezpečnostne preverené a nepredložia osvedčenie, nebudú môcť zúčastňovať na činnosti vymedzených orgánov Rady EÚ.
